OFFICE ORDER FOR SPECIAL ASSIGNMENT

This is in compliance with the directions of DPIIT that this office has undertaken a process to re-validate the TM Application processing where final decision was taken by Officers hired through Quality Council of India (QCI). The process shall revisit such cases at following levels:

- 1. TM Applications processed during the Examination Stage
- 2. TM Applications processed during the PARM Stage
- 3. TM Applications processed during the Show Cause Hearing Stage
- 4. TM Applications processed during the Opposition Stage
- 5. TM Applications processed during the Post Registration Stage

Accordingly, following group of Officers are hereby deputed to undertake the proposed action at different stages as per modalities given hereunder:

1. To Re-validate/ Revisit the applications processed at the Examination Stage:

The Level-1 Officer is directed and authorized to revisit the application as per provisions of the Trade Marks Act, 1999 and the Trade Marks Rules, 2017 (herein after called the 'law'). If he considers that the application has already been processed as per law, he may validate the same. Else, in appropriate cases, he may state the reasons and propose the suitable action including under Section 19 or Section 57(4) of the Act, as the case may be, to Level-2 officer. Thereafter, Level-2 officer is authorized to initiate the process as per proposal of Level-1 officer. In case Level-2 officer disagrees to the proposal of Level-1 Officer, he may, for reasons to be recorded in writing, validate the decision. The Head of Office (HO) of respective TMR branch shall take necessary steps to fix up hearing in recommended cases on priority basis before Level-2 Officers.

To carry out the given tasks, the IT Division of TMR is hereby directed to suitably develop/make arrangement in TM Module to process the TM applications as above said including hearing of matters in appropriate cases.

The System Administrator of TMR shall prepare a weekly report of work output by above said officers and regularly put up before O/o CGPDTM. In this regard, the IT Division of TMR shall provide a Report Module for proper monitoring and reporting of the work output.

The System Administrator of TMR is also directed to share the relevant TM application numbers/ data with all HOs of TMR. Accordingly, the HOs shall insure that in all cases where the TMR order is under appeal and pending before the Hon'ble Courts, the relevant data entry pertaining to "Legal Cases Details" is done through TM module and all records uploaded on e-records. So that the same may be perused by the Level-1 & Level-2 officers and they may take appropriate step/decision to keep the matter in abeyance till the final outcome of the matter before the Hon'ble Court. In appropriate cases, where the Hon'ble Court has already passed the order/direction, the same shall be complied with by the HO of appropriate TMR branch within the stipulated time and manner as per directions of the Hon'ble Court.

To minimise the public grievance, which may arise during the process and also with a view to finish the whole process in a time bound manner, it is also directed that each combination of officers at Level-1 and Level-2, as far as possible, shall work diligently on the given tasks and process 250 applications per day. In case of any difficulties regarding the rules and procedure, Level-1 and Level-2 officers may seek the guidance from following officers:
